COMMENTS:

- * #1 Dock can accommodate ships up to 801 ft long but will take part of the #2 dock.
- * The numer of barges allowed at a dock can either be two deep and /or two wide.
- * The #5, 5A, 5B, 6, 9,10, 11 and 12 docks cannot accomodate two barges end to end.
- * The #4, 5B, 6 and 12 docks cannot accommodate two barges side to side.
- * Can only have barges doubled up at #10 or #11 dock. Cannot doubled up at #10 & #11 simultaneously

CHARGES:

- Bunker and Lube Oil Lightering Barges will be charged **\$3,000** dollars for the first barge, and \$2,000 each additional barge.
- Chemical Lightering Barges must obtain approval and Pricing from Marketing at ph# 281-884-0323. The minimum charge will be **\$4 per Metric Ton, or a minimum of \$5,000**
- Vessel Layberth (w/prior approval) charges are **\$7,500** dollars for first 24 hours and **\$7,500** dollars for each 12 hours thereafter.
- A charge of **\$2,250** per delivery will be assessed for delivery of stores (including water) to vessels at ITC docks
- A charge of \$2,500.00 per barge will be assessed to comply with MARPOL Annex II regulations
- A charge of \$1.40 per 100 cubic feet of nitrogen, unless otherwise specified by contract
